RESOLUTION OF THE BOARD OF SUPERVISORS OF THE MIDTOWN MIAMI COMMUNITY DEVELOPMENT DISTRICT DECLARING A VACANCY IN SEATS 1, 2 AND 3 OF THE BOARD OF SUPERVISORS PURSUANT TO SECTION 190.006(3)(b), FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Midtown Miami Community Development District ("District") is a local unit of special-purpose government created by, and existing pursuant to Chapter 190, *Florida Statutes*; and

WHEREAS, on November 8, 2022, three (3) members of the Board of Supervisors ("Board") are to be elected by "Qualified Electors," as that term is defined in Section 190.003, *Florida Statutes*; and

WHEREAS, the District published a notice of qualifying period set by the Supervisor of Elections at least two (2) weeks prior to the start of said qualifying period; and

WHEREAS, at the close of the qualifying period, no Qualified Electors qualified to run for the three (3) seats available for election by the Qualified Electors of the District; and

WHEREAS, pursuant to Section 190.006(3)(b), *Florida Statutes*, the Board shall declare Seats 1, 2 and 3 vacant, effective the second Tuesday following the general election; and

WHEREAS, pursuant to Section 190.006(3)(b), *Florida Statues*, a Qualified Elector shall be appointed to the vacant seat within 90 days thereafter; and

WHEREAS, the Board finds that it is in the best interests of the District to adopt this Resolution declaring the seat available for election as vacant.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE MIDTOWN MIAMI COMMUNITY DEVELOPMENT DISTRICT:

SECTION 1. The following seat is declared vacant effective as of November 22, 2022:

Seat #1 (currently held by Joseph Padula)

Seat #1 (currently held by Lindsey Vicha)

Seat #1 (currently held by Alex Miranda)

SECTION 2. Until such time as the District Board appoints a Qualified Elector to fill the vacancy declared in Section 1 above, the incumbent Board Supervisor of that respective seat shall remain in office.

SECTION 3. This Resolution shall become effective upon its passage.

COVENANT IN LIEU OF UNITY OF TITLE

KNOW ALL MEN BY THESE PRESENT that the undersigned, MIDTOWN OPPORTUNITIES XIIIB LLC, a Delaware limited liability company MIDTOWN OPPORTUNITIES IXB LLC, a Delaware limited liability company, MIDTOWN MIAMI COMMUNITY DEV DISTRICT, MIDTOWN OPPORTUNITIES XIB LLC, a Delaware limited liability company and MIDTOWN OPPORTUNITIES XIIB LLC, a Delaware limited liability company (hereinafter, collectively, the "Owner") hereby makes, declares and imposes on the land herein described, this Covenant in Lieu of Unity of Title ("Declaration"), and the covenants running with the title to the land contained herein, which shall be binding on the Owner, all heirs, grantees, successors, assigns, personal representatives, and upon all mortgagees, lessees, and all others presently or in the future claiming any interest in the Property, as described below.

WHEREAS, MIDTOWN OPPORTUNITIES XIIIB LLC, the owner of that certain property located at 3055 N Miami Avenue in the City of Miami, Florida, as more particularly described on Exhibit "A" attached hereto and incorporated, as applicable (together, the "Property"); and

WHEREAS, MIDTOWN OPPORTUNITIES IXB LLC, is the owner of that certain property located at 3000 NE 1 Avenue in the City of Miami, Florida, as more particularly described on Exhibit "A" attached hereto and incorporated, as applicable (together, the "Property"); and

WHEREAS, MIDTOWN MIAMI COMMUNITY DEV DISTRICT, is the owner of that certain property located at 2997 N Miami Avenue in the City of Miami, Florida, as more particularly described on Exhibit "A" attached hereto and incorporated, as applicable (together, the "Property"); and

WHEREAS, MIDTOWN OPPORTUNITIES XIIB LLC, is the owner of that certain property located at 35 NE 29 Street in the City of Miami, Florida, as more particularly described on Exhibit "A" attached hereto and incorporated, as applicable (together, the "Property"); and

WHEREAS, MIDTOWN OPPORTUNITIES XIB LLC, is the owner of that certain property located at 2905 N Miami Avenue in the City of Miami, Florida, as more particularly

described on Exhibit "A" attached hereto and incorporated, as applicable (together, the "Property"); and

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Owner hereby agrees as follows:

1. <u>Recitals</u>. The above recitals and findings set forth preamble of this Declaration are true and correct and are hereby adopted by reference and incorporated herein as if fully set forth in this Section.

2. <u>Use of Property</u>. The Owner of the Property hereby agrees and declares that (i) for the purpose of this Declaration, the Property shall be considered as one plot and parcel of land, and (ii) so long as this instrument shall remain in effect, any and all conveyances or transfers of all or any portion of the Property by the Owner, its heirs, grantees, successors, assigns, or personal representatives shall be subject to the terms and restrictions of this Declaration as if any such heir, grantee, successor, assign, or personal representative were a party hereto or a signatory hereof.

3. <u>Term of Declaration</u>. The provisions of this Declaration shall become effective upon their recordation in the Public Records of Miami-Dade County, Florida, and shall continue in effect for a period of thirty (30) years after the date of such recordation, after which time they shall be extended automatically for successive periods of ten (10) years each, unless released in writing by the (i) then Owner(s) of the Property (or if any portion of the Property has been submitted to the condominium form of ownership, then by the association established to operate the condominium in lieu of all of the owners thereof) AND (ii) the Zoning Administrator and Directors of the Departments of Resilience and Public Works, Planning, and Building of the City of Miami, subject to the approval of the City Attorney as to legal form and correctness, or their respective designees or successors, upon the demonstration and affirmative finding that the same is no longer necessary to preserve and protect the Property for the purposes herein intended.

4. <u>Covenant Running with the Land</u>: This Declaration, once approved for legal form and sufficiency by the City Attorney, and accepted by the City of Miami, or the respective designees, shall run with the land and be binding upon the heirs, grantees, successors, personal representatives and assigns, and upon all owners, future owners, mortgagees, lessees and others presently or in the future having any interest in the Property.

5. <u>Amendments, Modifications, Releases</u>. The provisions of this Declaration may be amended, modified, or released by a written instrument executed by the (i) then Owner(s) of the Property (or if any portion of the Property has been submitted to the condominium form of ownership, then by the association established to operate the condominium in lieu of all of the owners thereof) and (ii) the Zoning Administrator and Directors of the Departments of Resilience and Public Works, Planning, and Building of the City of Miami, subject to the approval of the City Attorney as to legal form and correctness, or their respective designees or successors upon the demonstration and affirmative finding that the Covenant is no longer necessary to preserve and protect the Property for the purposes herein intended. All amendments, modifications, or releases of this Declaration shall be executed in the manner enumerated in this section and shall be recorded

in the Public Records of Miami-Dade County, Florida in order for the amendment, modification, or release to be valid and effective.

6. <u>Inspection and Enforcement</u>. It is understood and agreed that any official inspector of the City may have the right at any time during normal business hours to enter upon the Property for the purpose of investigating the use of the Property and for determining whether the conditions of this Declaration are being complied with. Enforcement of this Declaration shall be by action against the parties to this Declaration or persons violating or attempting to violate any covenants in this Declaration or the then Owner(s) at the time the violation is committed. This enforcement provision shall be in addition to any other remedies available at law, in equity, or both. The violations may also be enforced by City Code, Chapter 2, Article X, titled Code Enforcement.

7. <u>Severability</u>. Invalidation of any of these covenants by judgment of a court shall not affect any of the other provisions, which shall remain in full force and effect.

8. <u>Cumulative and Waiver</u>. All rights, remedies and privileges granted herein shall be deemed to be cumulative and the exercise of any one or more shall neither be deemed to constitute an election of remedy, nor shall it preclude the party exercising the same from exercising such other additional rights, remedies, or privileges as may be available to it.

9. <u>Declaration Binding on Subsequent Owners</u>. In the event of multiple ownership subsequent to the approval of this Declaration, each of the subsequent owners shall be bound by the terms, provisions, and conditions of this Declaration. Further, except for sales to condominium owners, the Owner agrees that it will not convey portions of the subject Property to such other parties unless and until the owners and such parties shall have executed and mutually delivered, in recordable form an instrument to be known as an "easement and operating agreement" which shall include, but is not limited to:

(i) Easements in the common area of each parcel for ingress to and egress from the other parcels;

(ii) Easements in the common area of each parcel for the passage and parking of vehicles;

(iii) Easements in the common area of each parcel for the passage and accommodation of pedestrians;

(iv) Easements for access roads across the common area of each parcel to public and private roadways;

(v) Easements for the installation, use, operation, maintenance, repair, replacement, relocation, and removal of utility facilities in appropriate areas in each such parcel;

(vi) Easements on each such parcel for construction of buildings

and improvements in favor of each such other parcel;

(vii) Easements upon each such parcel in favor of each adjoining parcel for the installation, use, maintenance, repair, replacement, and removal of common construction improvements such as footing, supports, and foundations;

(viii) Easements on each parcel for attachment of buildings;

(ix) Easements on each parcel for building overhangs and other overhangs and projections encroaching upon such parcel from adjoining parcel such as, by way of example, marquees, canopies, lights, lighting devices, awnings, wing walls, and the like;

(x) Appropriate reservation of rights to grant easements to utility companies;

(xi) Appropriate reservation of rights to road rights-of-way and curb cuts;

(xii) Easements in favor of each such parcel for pedestrian and vehicular traffic over dedicated private ring roads and access roads;

(xiii) Appropriate agreements between the owners of the several parcels as to the obligation to maintain and repair all private roadways, parking facilities, common areas, common facilities, and the like; and

The "Easement and Operating Agreement" shall be recorded by the Applicant/Owner and a copy furnished to the Zoning Administrator and Directors of the Departments of Resilience and Public Works, Planning, and Building of the City of Miami, or their respective designees or successors. These instruments or portions may be waived if approved by each of the directors of Resilience and Public Works, Planning, and Building Departments, as well as the Office of Zoning, or their respective designees, if the provisions are inapplicable to the subject Property. Such provision may be modified or amended by such parties (or the applicable association governing such parties) without approval or joinder by the directors, or their designees, if it will be constructed, conveyed and operated in accordance with an approved site plan.

10. <u>Counterparts/Electronic Signature</u>. This Declaration may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute but one and the same Declaration. The parties shall be entitled to sign and transmit an electronic signature of this Declaration (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Any party providing an electronic signature agrees to promptly execute and deliver to the other parties an original signed Declaration upon request.

11. <u>Recordation</u>. This Declaration will be e-recorded by the City of Miami, at the Owner's expense, in the public records of Miami-Dade County, Florida upon full execution.

52 SECOND ORDER OF BUSINESS Public Comments

Resident June Marcus asked about the future use planned for the area known as the entertainment block. Mr. Padula stated there are currently no plans for that lot. Ms. Cerbone stated the CDD does not own the parcel; it is private property within the CDD boundaries. Mr. Padula stated Midtown Opportunities is the Landowner of the property. Ms. Samuel stated she was advised that the trailer will be removed from the property.

59 Ms. Marcus asked if minutes of the meeting will be available, since she could not hear 60 everyone. Ms. Cerbone stated that meeting minutes are posted on the website as part of the 61 next meeting agenda. If the Board meets next month, the minutes will be included in the 62 agenda posted on the website for that meeting. The final meeting minutes are not posted as 63 executed, standalone documents on the CDD website until they are reviewed and approved by 64 the Board.

65 Resident Desiree Cachette stated her questions are about the dog park and the budget. 66 Ms. Cerbone suggested the budget questions be addressed during the budget Public Hearing. 67 There is currently not a dog park but this will be discussed during the Operations Manager 68 Report. Ms. Wald stated the dog park has been discussed over the last two to three years but 69 has not moved past the discussion phase. She noted that meetings are open to the public and

public comments are welcome at meetings regarding items on or not on the agenda. Ms.
Samuel stated, while the dog park was originally planned in conjunction with the kid park, the
decision was made to proceed in stages to determine the best use of the park. One issue to be
addressed is that the insurance company recommended separate areas for small dogs and large
dogs but there is not enough space. Other obstacles include remediation and, while it is a
budgeted item, it is currently unclear if the project will proceed.

Resident Gary Wong expressed concern about truck traffic since Trader Joe's opened and asked if these meetings are the appropriate venue to voice these concerns. If so, he wanted to know the next steps and how residents can help. He is concerned because four cars were stolen from the garage in the last month.

Mr. Padula stated he also observed increased traffic. Ms. Wald stated, while the CDD owns the two garages, most streets are owned by the City and some are owned by the County and those entities are responsible for traffic management. Regarding crime, while the CDD has on-site security and concerns can be raised at CDD meetings, the CDD has no police powers; the City Commission is the main entity to contact for a mixed-use community such as this.

Mr. Wong discussed parking issues related to a restaurant/nightclub in their residential building and noted that building management mandates delivery time windows and requires an on-duty manager for receiving for the nightclub and there is only one service elevator. He felt that residents should work together to address the issues and asked what else can be done.

Mr. Padula stated Trader Joe's and the building's management company manage the parcel; they control elevator access and loading zones. Ms. Samuel stated she will provide contact information for the appropriate parties.
