Mpark Park Restoration

We are currently working on doing some restoration projects in the park. Due to lack of water for irrigation available, we have had landscape die, which was acting as a barrier in front of the storm drain. Hence as a solution, we installed a black metal fence around the area and will install artificial turf.

We are also planning to replace and separate the pumps for the two fountains in the entrance as the current pump has a leak and is causing sink age on the north west side of the park This would require closing the entrance, removing the paver's and have the plumbers install new piping. We are also installing new fountain lights.

The leak form the pump is causing damage on the north west side of the park We will have to cap the pipes and restore the affected area by removing teh turf, restoring the area and reinstalling the turf.

We will keep you posted with the progress of these projects

East Coast Infrastructure

We are getting continuous damage to the same to areas on wast coast ave. One is across form Midtown Two . we are installing bollards because they park on the sod and cause us to replace it often.

The second area is right before yard 8 on the delivery trucks drive over the planter on the turn causing the sod to be damaged we are using concrete foundation and turf in that area so it can withstand it, if a truck hits it,

Contact-less Readers

The total cost of the contact-less EMV upgrade is \$26,454.68.., it increases the customer ease of use but as demand continues to accelerate for contact less payment options our losses will only continue to accelerate.

Bar Code Ticket

Presently we have mag-stripe tickets at Midtown Miami. The issue is that a consistent 3-4% of our total tickets get demagnetized and are unreadable at the payment stations and exit lanes. This creates backups upon egress and is a general inconvenience to a number of our guests. The only solution to this is to upgrade the ticket dispensers from a magnetic system to a bar code ticket system. The total cost for this system upgrade would be \$71,260.93 and I was able to have it broken out into 3 payments to ease the cost.

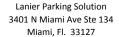
