ALL VALIDATIONS, DISCOUNT CARDS, MONTHLY OR ANNUAL PARKING PASSES ARE PAYABLE IN ADVANCE AND CAN BE PURCHASED AT THE DISTRICT MANAGEMENT OFFICE DURING REGULAR BUSINESS HOURS.

* The Pick-up/Drop-off Validation program is limited to 5,000 validations per year and is specifically intended for those patrons who must drop-off an item and then return later in the day to retrieve the item or who have phoned in an order and must pick-up that order (i.e. prescriptions or pet grooming). Any stay that exceeds 30 minutes shall result in a parking fee of \$2.00. Validations shall be picked up in the CDD Management office and will be issued on a limited

- basis by the District Manager or his or her designee. This program will be reviewed by the CDD Board of Supervisors no later than August 2015.
- ** Payable in advance for small-scale events like film crews, company training, inventory companies, construction work, etc., subject to final approval of the District Manager.
- *** The Residential Short Term Condominium Valet shall be paid in advance based on the limited number of spaces approved by and at the discretion of the District Manager or his or her designee.
